Foam AID should be added to the any mixture where foam may occur before adding any other chemicals or any additional surfactant. Agitation is recommended to aid in dispersion of the various components.

Situation	Purpose	Application Rate	Critical Comments
Agricultural Spray Tanks	Prevention of Foam Formation	20mL per 100 Litres of mixture	Add water to tank first then add Foam AID while agitator is running. Add other chemicals to the tank. If mixture is recirculating add 40mL/100L of mix.
	Eradicate Existing Foam Formation	60mL per 100 Litres of mixture	If foam has already occurred stop tank agitation and add Foam AID per 100 litres across the surface of the foam. When the foam starts to drop recommence agitation of the mixture again.

SAFETY DIRECTIONS

Do not swallow. Avoid contact with eyes and skin. Wear rubber gloves, overalls and goggles and face shield. Wash hand with soap and water after use.
