DIRECTIONS FOR USE

- Shake well before each use. For maximum performance, apply at recommended rates followed by a light irrigation to move product into the root zone.
- Keep container closed when not in use.
- Mix in spray tanks with water and agitation.
- Ideally, HydroForce Rapid should be applied each time water is applied onto the turf surface.

RECOMMENDED RATES

Situation	Rate per 100m ²	Rate per hectare	Comments
Boom Spray (Shorter Term Residual)	50mL	5L	Apply in no less than 400L/ha of water. Irrigation is not critical but is recommended to ensure product effectiveness. Repeat treatments at the desired application frequency.
Boom Spray (Enhanced Residual Performance)	200-500mL	20-50L	Apply in no less than 600L/ha of water. Irrigation is recommended to ensure product effectiveness. Repeat treatments at the desired application frequency.
Fertiliser and pesticide placement	20-50mL	2-5L	To ensure optimal placement of soil targeted pesticides and fertilisers tank mix with HydroForce Rapid. Irrigation is not critical but is recommended to ensure product effectiveness.
Injection (Fairway and Sportsfields)	20-50mL	2-5L	To ensure optimal water usage, apply monthly or as necessary. The greater the frequency of application the greater the water use efficiency. On a volume basis do not go below 10L per Megalitre of irrigation water.
Ornamental garden beds & landscaped areas	5mL / 10L of water		Sufficient to drench area of up to 5m ² . Water in well following application. Apply as necessary.

COMPATABILITY: Tank mix combinations with HydroForce Rapid have not been tested on all varieties under all possible growing conditions.
