# **Statement of Hazardous Nature**

This product is classified as: Xn, Harmful. Xi, Irritating. Hazardous according to the criteria of SWA.

# Section 3 - Composition/Information on Ingredients

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. ### **Section 4 - First Aid Measures**

# **Section 5 - Fire Fighting Measures**

#### **Section 6 - Accidental Release Measures**

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. # Section 7 - Handling and Storage

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas.
