FOLIAR SPRAY APPLICATIONS

Crop	Pest	Rate	Critical Comments
Elm trees up to 4 m tall	Elm leaf beetle larvae (Pyrrahalta luteola)	Subsoil injection. 2.5 - 5 mL per tree, in 40 mL water. Soil drench 2.5 – 5 mL per tree, in 1 L of water.	Apply at first sign of aphid infestation. Apply 2 weeks after flowering to allow several weeks for the chemical to be taken up by the tree and become effective. Uptake will be assisted by applying when soil is moist, tree is actively growing, and rainfall or watering can help move the chemical to the roots. For nursery stock either apply by subsoil injection in 40 mL water and water in or mix in 1 L water and pour over the soil. For amenity situations where trees are planted apply using a soil injector to a depth of 10 cm applying in 40 mL of water or as a soil drench in 1 L of water to the soil at the base of the tree. Ensure the mixture penetrates the soil around the trunk base and does not runoff. In general, the larger the tree and the higher the insect pressure the higher the rate required.

Some naturally occurring insect biotypes resistant to RETREAT 200 SC and other Group 4A insecticides may exist through normal genetic variability in any insect population. The resistant individuals can eventually dominate the insect population if RETREAT 200 SC or other Group 4A insecticides are used repeatedly. The effectiveness of RETREAT 200 SC on resistant individuals could be significantly reduced. GROUP 4A INSECTICIDE

MIXING

Soil drench:

Half fill application container (watering can or similar) before adding product and filling container. Use immediately after mixing.

Injection method in plantations when using spray tank:

Measure the required amount of product to a partially filled spray tank and then add the remainder of the water. Ensure agitation is maintained during tank filling and whilst applying.

DO NOT let prepared spray solution sit in spray tank overnight.

COMPATIBILITY

It is advised to test water quality which may vary considerably with location, as well as all mixtures prior to mixing commercial quantities.

PROTECTION OF HONEYBEES AND OTHER INSECT POLLINATORS

Highly toxic to bees. Harmful to bee brood. Clothianidin has systemic action. Residues may remain toxic to bees several days after application. **DO NOT** apply to trees pre-bloom, or from the onset of flowering until 2 weeks after flowering is complete. Before applying the product, notify beekeepers to move hives to a safe location with an untreated source of nectar and pollen, if there is potential for managed hives to be affected by residues transferred by foraging bees, spray, or spray drift. Ensure the mixture penetrates the soil around the trunk base to avoid runoff, especially on hot days as bees could use treated water remaining on the soil surface as a source of water for the hive.
