DIRECTIONS FOR USE

- Shake well before each use. For maximum performance, apply at recommended rates.
- Keep container closed when not in use.
- Mix in spray tanks with water and agitation.

RECOMMENDED RATES

Situation	Length of control	Rate per 100m ²	Rate per hectare	Comments
Dew Prevention and Control	1-2 days	20-30mL in 10L of water	2-3L in 1000L of water	Apply in water on day of night game or day of golf tournament to help prevent dew formation.
	3-5 days	40-50mL in 10L of water	4-5L in 1000L of water	Apply in 1000L/ha water to give longer term control. Can cause discolouration on some turf varieties. Test on a small area to determine suitability with turf variety prior to large scale usage.

COMPATABILITY: Do not tank mix HydroForce DewPRO unless prior use (including a jar test and strip test) has shown the combination physically compatible, effective, and non-injurious under your conditions.

STORAGE AND DISPOSAL

Keep container tightly closed. Store in original container only. Keep away from open flame or intense heat. Keep in a secure storage area. Do not add water to the contents of this container. Triple rinse container, empty rinse water into spray or stock tank. Dispose of empty containers in accordance with local regulations.
